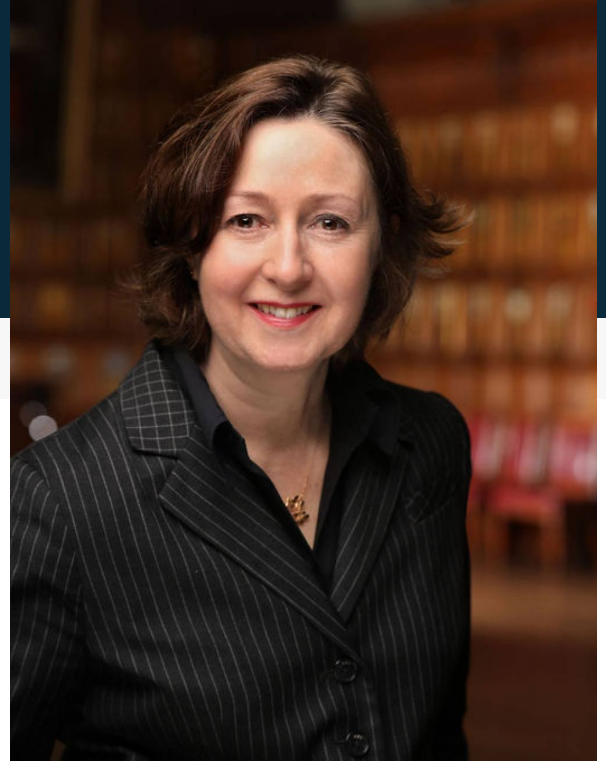

R v N. Instructed as leading junior representing a defendant charged with a 'Ponzi' fraud in which investors transferred £8.9 million believing that their money would be used for foreign exchange trading.

R v H & others. Instructed to represent a defendant charged with conspiracy to commit fraud by false representation. The case concerns the submission of fraudulent Research and Development Tax Relief claims to HMRC with an intended loss of £6.8 million.

R v H. Represented a medical professional accused of multiple sexual assaults on a patient. Acquitted.

TRA v S. Represented a teacher who faced allegations of inappropriate touching of a pupil. The teacher had already been acquitted of all criminal charges. After legal argument over the admissibility of the evidence the TRA wanted to rely on, all the allegations were dropped.

PS R Represented a police officer at a police misconduct hearing who faced allegations of using racist and insulting language on multiple occasions.

D. Supt. M. Represented police officer at an accelerated police misconduct hearing. Secured a final written warning.

GMC v Dr C. Represented a GP who faced allegations of multiple failures and dishonesty. Successful legal argument to exclude evidence led to the GMC withdrawing all but one of the dishonesty allegations. Secured a finding of no impairment.

Serious crime:

Claire is regularly instructed as both leading junior and junior counsel to deal with single and multi-handed cases involving serious violence, drug supply and modern slavery offences. She has particular experience in dealing with sensitive cases involving serious sexual offences, including historic offences and offences against children and is

used to dealing with cases in which special measures are required, including the use of the section 28 provisions for pre-recorded cross-examination.

Notable serious crime cases:

R v L (2020)

Prosecution counsel. Historic sexual offences against a step-daughter. Oxford Crown Court.

R v Y (2020)

Defence counsel. A 16-year-old schoolboy who stabbed a rival. Isleworth Crown Court.

R v T (2019)

Defence counsel. Shop owner accused of a modern-day slavery offences. Blackfriars Crown Court.

R v J (2019)

Prosecution counsel. Historic sexual offences against a foster daughter. Aylesbury Crown Court.

R v M (2019)

Junior prosecution counsel, led by Kate Lumsdon QC. Historic sexual offences committed by a Roman Catholic priest against children in his congregation in the 1970's. Aylesbury Crown Court.

R v N (2018)

Prosecution counsel. Defendant who carried out a campaign of stalking her ex-boyfriend; sending malicious communications to both him and his work colleagues and perverting the course of justice, which involved her staging her own kidnap and then hiding in Scotland. Snaresbrook Crown Court.

R v. C [2017]

Defence counsel. Historic sexual offences against his sister.

R v H & Others [2015]

Junior defence counsel led by Vince Coughlin QC. Represented the first defendant, an 18 year old charged with multiple counts of rape and gang rape of a young and vulnerable complainant over a two year period.

Financial crime:

Claire has significant experience in multi-handed cases involving allegations of fraud and money-laundering. Her attention to detail and meticulous preparation mean that she has the skills and temperament required for these types of cases.

Notable financial crime cases:

R v G & others (2020)

Leading prosecution counsel. Multi-handed conspiracy to launder money; large quantities of cash collected around the UK and intercepted at airports (Op Leadbelly).

R v. Lawrence [2015]

Prosecution counsel. 78 year old defendant who defrauded his partner of £160,000 to fund his affair with his mistress aged 27 years. Croydon Crown Court.

R v. O & Others [2013]

Leading prosecution counsel. Six defendants charged with conspiracy to facilitate a breach of immigration law.

R v. Mayiger & Others [2012]

Leading prosecution counsel in a conspiracy to defraud. Non-transferrable tickets to Premiership football matches and Wimbledon Lawn Tennis Championships were purchased and then sold online at inflated prices. Members of the public who has purchased tickets were stopped when they attended the matches and in some instances were refused entry. Southwark Crown Court.

Professional discipline and regulatory law:

Claire is known as a leading practitioner in the field of professional discipline and regulatory law. She regularly defends registrants before fitness to practice committees and is sought after for cases which involve sexual misconduct or require consideration of third-party material.

She has particular experience before the Nursing and Midwifery Council, the Health and Care Professions Council, General Pharmaceutical Council and at General Medical Council hearings before the Medical Practitioners Tribunal Service.

Claire also regularly appears on behalf of medical professionals at inquests, including those requiring a jury.

Claire is a Legal Adviser to the General Dental Council fitness to practice committees.

Notable professional discipline and regulatory law cases:

Architects Registration Board v GDS (2023)

Defended an architect charged with unacceptable professional conduct in respect of the adequacy of terms of

engagement provided to a client.

Ministry of Defence Police v PC KPG (2022)

Defended a transgender officer who faced allegations of inappropriate and one-sided romantic infatuations with three women, sent large quantities of romantic or suggestive correspondence and behaved in a way that amounted to harassment. The officer had been formally warned about the behaviour but persisted. There were also allegations of stroking and punching a colleague's arm and kissing his ear.

The case involved sensitive issues because the officer who, before being suspended, was a firearms officer and had been in the Ministry of Defence Police during transition. At the time of the final hearing the officer had mental health vulnerabilities which had to be carefully managed during the hearing.

The Venerable Derek Andrew Broom v The Reverend J B (2022)

Defended Reverend JB at a Bishop's Disciplinary Tribunal hearing. Reverend JB faced charges of conduct unbecoming or inappropriate to the office and work of a clerk in Holy Orders and with a failure to comply with the duty to have due regard to the House of Bishops' guidance on safeguarding children and vulnerable adults. This was one of the first cases in which a failure of the duty to have due regard has been litigated and concerned Reverend B's conduct in handling a complaint made by a survivor of historic sexual abuse against a man who was still a member of the parish.

Teaching Regulation Agency v DM (2021)

Defended a teacher facing allegations of unacceptable professional conduct and /or conduct that may bring the teaching profession into disrepute, arising out of an incident in which he failed to take timely action to stop a classroom incident and to safeguard the wellbeing of a pupil.

Ministry of Defence Police v Police Sergeant DH (2021)

Defended Police Sergeant DM during his Ministry of Defence gross-misconduct hearing arising out of allegations that he had plagiarised part of his portfolio of work required to be signed off in order to complete his promotion to Sergeant.

Inquest touching upon the death of B B K (2021)

Acted for a dietician at the inquest into the death of a man who died at a residential care home whilst held under the Mental Health Act.

NMC v L & others (2019)

A senior nurse who faced serious misconduct charges arising from her employment at HMP Liverpool. The prison was part of the failed Liverpool Community Health NHS Trust, which no longer exists, and which was reviewed in the Kirkup inquiry, published in 2018.

GMC v P (2018)

A doctor accused of using his mobile phone camera to view a male colleague under the partition between two toilet cubicles.

NMC v F (2017)

Defended a psychiatric nurse accused of historic sexual misconduct against a patient in his care.
