Liam joined Chambers as a tenant in October 2023 following his successful completion of pupillage.

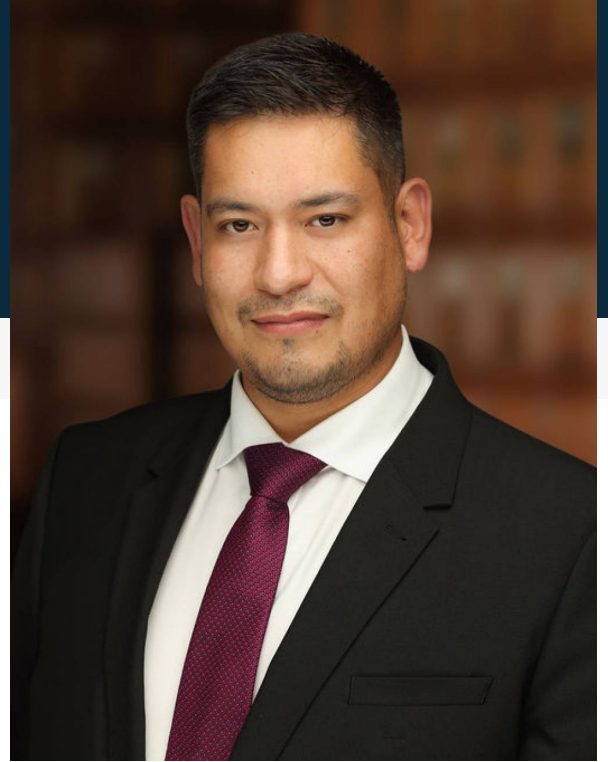
